- IV. EL Program and Progress Mrs. Quijada provided a <u>CUHSD EL Program Presentation</u> also provided a hard copy of the <u>CUHSD English Learners data</u>, district wide goals for the EL program and areas of growth and needs.
- Q. Mr. Urquidez, "What does the LPAC test? Is it reading, writing, grammar?
 - A. Mrs. Quijada, "Speaking, Listening, Reading, and Writing."
- Q. Urquidez: "How does a student exit the program?"
 - A. Mrs. Quijaja, "Students must score an overall ELPAC Level 4; 3 or 4 in ELA on CAASPP exam; SOLOM teacher evaluation; Parent consultation and agreement; GPA of 2.0 higher
- Q. Urquidez: "So, you don't automatically redesignate students. There is a process with parents involved. What happens when parents are not in agreement?"
 - A. Mrs. Quijada, "Parents are always involved and informed. We had one situation where the parent did not want the student to exit the program. The student was not speaking English at home, so the parent wanted to keep the student in the program to make sure the speaking skills were developed. We honored the parent's request."
- Q. Mrs. Plancarte, "Do we provide incentives for students scoring an overall ELPAC Level 4?"
 - A. Mrs. Quijada, "Not right now. Maybe this is something we should consider since there are CAASPP incentives and this is a state exam as well."
- Q. Mr. Henderson, "How can the library support the EL program?"
 - A. Mrs. Quijada, "We could use more Latin authors to engage students. For example, Reyna Grande, Julio Cortoza and Isabel Allende. I can put a list of authors together for you."
- Q. Mr. Henderson, "Are there any EL dollars available to provide this support?"
 - A. Mrs. Quijada, "My budget is very limited, but let me see what we can do."
- V. <u>District LEA Parent and Family Engagement Policy Evaluation</u> (ESSA Section 1116 a., CE 01 CE1.2 CE 1.6) (Mrs. Apodaca) One of the recommendations/findings stated by the FPM team was that we needed to include more parent participation in the development of our Parent and Family Engagement Policy.
